Community Lighting -

Silver Pole (PEC)

Individual Poles: **several repaired in Oct. / Nov.**

Black Pole (SCA)

Firecracker Dr. - **warehouse missing head, pole @ Turnersville, all on list for repair 2026 budget**

Community Entrances -

Sunbright Boulevard - **column logo lighting: exploring other repair options**

Sundown Avenue - **light fixture, column capstones: capstones exploring options w/ secondary contractor, waiting on proposal from contractor for lighting fixtures**

Main St. & FC - **column & retaining wall capstones: exploring repair option w/ secondary contractor**

## 1) Infrastructure - continued

### Community Bridges -

Sunfield Pkwy - lighting fixture & retaining wall capstones: lighting fixture repair in 2026 budget, capstone repair is being explored with secondary contractor

### Community Mail Centers -

Aura Drive - repair approved and contractor notified. Contractor waiting on parts and will repair once parts are secured.

### Community Roadways -

Discussion with Aaron Jones-Field Operations Super -

- Some Sunfield roadways are county @ 30%, some are SMUD @ 70%.
- Open to engage with Fire Marshall and establishing "No Parking" on one side of the street if it is too narrow for emergency vehicles to pass with vehicles parked on both sides of the roadway.
- Hays Co. will not red paint curbs.
- Alternating sides of road with days of week is not something he believes will work, unless the subdivision adopts as a Community Charter amendment. It will be up to the developer/subdivision to provide signs.
- Restrictions for heavy loads are not possible due to public use. Aaron questioned how restrictions could be written which would allow for moving vans, or supplies for individual homeowners but not contractors?
- He acknowledged heavy haulers do great damage to roadways, but it's difficult to restrict on public roads.
- Meeting Wednesday with Buda Planning Dept. to discuss road projects, such as Main Street improvements east of I35. Discussed right turn issues for East bound traffic turning right onto Fire Cracker (John to send him an example). The traffic light at Fire Cracker and Main is also a topic.
- Aaron noted upcoming roadwork on Satterwhite Rd. and South Turnersville Rd.
- Aaron offered to meet if desired, either at his office or he'd meet with our group in Buda.

Sinking Roadway - Pepperbark Loop repair is responsibility of MUD #3 / Ginger St. - report to SMUD #4  
Sunfield Pkwy - road repair: Mike has no word from Hays County. Crosswalk striping at mid Lazy River parking: gathering proposal.

Promenade Pkwy - Crosswalk striping at mid Lazy River parking: gathering proposal for crosswalk & handicap parking striping. Mike is also looking into getting striping done in some areas of Sunfield that include roundabouts and cross walks.

Community Fire Hydrants - red curb striping completed in phase 1 and 4. We are almost done with Phase 2, we are ordering more fire lane paint. Alexander discussed hydrant locations with Fire Dept. and some hydrants are mapped on Hays Co. GIS, but mapping is not up to date.

### Community Fencing - Common Area Fence Stain Status -

Main Street Whisper Ridge - on list, need board approval.

Neighborhood Fence Stain - The rest that were pending due to weather, will be completed next week.

### Community Sidewalks -

Model Home - Autumn Sage - Lakeridge Neighborhood connector walkway – Mike waiting on proposals for silt fencing install Ang getting an ETA from SunGrow Construction for backfill and hydro mulching.

Esperanza - Leadtree Loop Gulley connector walkway & bridge - Mike waiting on proposals for silt fencing install and getting an ETA from SunGrow Construction for backfill and hydro mulching.

Perimeter walkway by northwest Sunbright pond lifting – Tom entered work order in portal #429

Request for sidewalk adjacent to Esperanza along gulley between CDS & Sunfield Pkwy – this is in the 2026 budget proposal as part of sidewalk repairs

Purple Pipe Irrigation Retrofit - waiting on installation of pump head in Sunfield Parkway Pond and connecting pipe segment under Sunbright bridge.

Landscape Maintenance Schedule Map: version x – Need Casey to send updated version from her computer as she finalized the graphics and will upload to the resident portal next week.

Sunbright Amenity Center: Lap Pool / Splash Pad / Playground / Pavilions / Dog Park / MP Field

Jr. Olympic Lap Pool - deck surface replacement in 2026 budget - pending approval, bathrooms winterized

Wading Pool - refresh complete, deck surface replacement in 2026 budget - pending approval

Pavilion - lighting upgrade in 2026 budget - pending approval

Playground - repairs complete

Dog Park - considering repair or replacement of interactive features

Multipurpose Field (proposed) - proposal in 2026 budget - pending approval

Teen Activity Area (proposed) - working on draft of design for teen challenge course

Sunfield Lazy River Amenity Center: Lazy River / Reunion Pavilion / Playground (proposed) -

Lazy River - leaks repaired and surface refinished, water loss greatly reduced, static test to be performed.

Flow circulation pumps #10, #5, #1 have performance issues and are in process to be repaired prior to opening. Bathrooms winterized, Volleyball net & designation of an activity pool under consideration.

Reunion Pavilion - video monitoring signs installed and graffiti has currently stopped

Lakeside Amenity Center: Lazy River / Splash Pad / Playground / Picnic Pavilions -

Lazy River - deck heaving and other items all on punch list for contractor resolution, bathrooms winterized.

Splash Pad - torn pad on punch list for contractor resolution. Investigating addition of single restroom.

Playground - sidewalk from parking to playground in 2026 budget

Individual Picnic Pavilions -

Neighborhood Playgrounds:

Razzmatazz / Dandy / Silktassle - various repairs in process and planned

Manzanita / Lemonball - working on proposals for addition of playground equipment

Community Ponds:

Sunfield Parkway Ponds - purple pipe pump installation, aeration system install, landscaping - all pending
